REGULAR MEETING June 4, 2024

The regular monthly meeting of the Cooke Township Supervisors was held at the Township Building, 1700 Centerville Road, Newville, PA. Present at the meeting were Supervisors' Strayer, Batt and Sangialosi, Solicitor Matthew McKnight, Planning Committee Chairman, Andre Weltman, Robert Kough, Jr., Emergency Coordinator, residents, Jeff and Margie Schmidt, Becky Moorhead, Samantha & Logan Kistler, and Secretary Frantz.

Supervisor Sangialosi motioned to approve the minutes of the May 6, 2024 meeting, second by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to approve the Treasurer's report as of May 31, 2024, second by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to approve the checks list for June 4, 2024, second by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to approve the ratification of checks written after the May 6, 2024 meeting, second by Supervisor Batt. Vote unanimous.

Drew up plan for Leeper Farm Rd. for Dirt and Gravel project. Fixed washout on Murphy and Ice house. Prepped bay for concrete pad. Cut up tree on Bendersville Road and cleaned tree off of Leeper Farm Road. Greased and put air in tires on backhoe. Caught people dumping brush on Ridge Road and reported to forestry. Cleaned drain out on High Mountain. Fixed potholes on Peach Orchard and High Mountain roads. (5 -ton 2A's) Patched potholes on quarry and Ridge Roads. Cut up tree on Bendersville Lane. Spread 30-ton 2A's on Peach Orchard. Spread 5-ton 2A's on Old Shippensburg. Purchase 2 tires for F550. Cut limbs on Old Railroad Bed Road. Cut ditches and blew Michaux Road for paving. Flagged for Schlussers while paving Michaux Road area.

Secretary Frantz called Danatech for service of security alarm system. Two alarms were reported with no issue noted. Schlussers finished the blacktop on Michaux Road area.

Planning committee chairman, Andre Weltman reported the county has been informed of address changes that will take effect July 15, 2024. Sarah Fuhrmeister is the coordinator for address changes. She will notify all other county officials.

Supervisor Sangialosi gave update from the WCCOG meeting. Representative Barb Gleim distributed two draft pieces of legislation for the food processing residual. Ed Strayer and Andre Weltman attended the outreach planning meeting. Andre gave an update on the small bridge program and Toms Run Bridge from the outreach meeting.

Solicitor McKnight stated that he is waiting for a draft 2-year contract with Zito.

Supervisor Sangialosi motioned to have Solicitor McKnight draw up an agreement concerning Logan Kistler's use of existing structure. Mr. Kistler will sign

agreement along with the Supervisors. A building permit will then be issued. Seconded by Supervisor Batt. Vote unanimous.

Gravel Grinder race will be held June 30, 2024. Chief Kough received the EAP and a check for donation to the Fire Police for flagging at Rt. 233 and Ridge Road.

Emergency coordinator Robert Kough Jr. attended the Hazard Mitigation meeting. It is time for the 5-year review. Must be completed and adopted by December 15, 2025.

Becky Moorhead read a portion of the Constitution.

Supervisor Strayer motioned to adjourn the meeting, second by Supervisor Batt. The meeting adjourned at 8:09 P.M.
