The reorganization meeting of the Cooke Township Supervisors on January 2, 2024 at 7:30 PM at the Township Building, 1700 Centerville Road, Newville, PA. Present at the meeting were Supervisors' Batt, Strayer, and Sangialosi, Solicitor Matthew McKnight, Planning Committee Chairman, Andre Weltman, Emergency coordinator, Robert Kough Jr., resident Becky Moorehead and Secretary Janet Frantz.

Supervisor Sangialosi called the meeting to order and led the group in the pledge to the Flag.

Supervisor Sangialosi appointed Supervisor Batt as the Temporary Chairman, second by Supervisor Strayer.

Supervisor Sangialosi appointed Janet E. Frantz as Temporary Secretary-Treasurer, second by Supervisor Batt.

Supervisor Batt motioned to appoint Supervisor Sangialosi as Chairman, second by Supervisor Strayer. Vote unanimous.

Supervisor Strayer motioned to appoint Supervisor Batt as Vice Chairman, second by Supervisor Sangialosi. Vote unanimous.

Supervisor Batt made a motion to appoint Janet E. Frantz as Secretary-Treasurer, second by Supervisor Sangialosi. Vote unanimous.

Supervisor Sangialosi made a motion to adopt, approve and sign Resolution 2024-01, Appointments and Establish Monetary Rates for 2024, second by Supervisor Strayer. Vote unanimous.

Supervisor Batt made a motion to adjourn the meeting, second by Supervisor Sangialosi. The meeting adjourned at 7:33 PM.

**REGULAR MEETING  
JANUARY 2, 2024**

The regular monthly meeting of the Cooke Township Supervisors was held following the reorganization at the Township Building, 1700 Centerville Road, Newville, PA. Present at the meeting were Supervisors' Strayer, Batt and Sangialosi, Solicitor Matthew McKnight, Planning Committee Chairman, Andre Weltman, Emergency coordinator Robert Kough Jr., resident Becky Moorehead, and Secretary Frantz.

Supervisor Sangialosi motioned to approve the minutes of the December 5, 2023 meeting, second by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to approve the Treasurer's report as of December 31, 2023, second by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to approve the checks list for January 2, 2024, second by Supervisor Strayer. Vote unanimous.

Supervisor Sangialosi motioned to approve the ratification of checks written after the December 5, 2023 meeting, second by Supervisor Batt. Vote unanimous.

Roadmaster Kutz flushed the backhoe radiator again and put in new antifreeze. Removed and replaced tractor O-ring. Fixed holes on Ridge, High Mountain, Peach Orchard, Cold Springs, Leeper Farm and Ice House roads. Blew leaves off of Old RR Bed, Quarry and Murphy roads. Removed limbs off of roads and cut trees up on various roads after storm. Put spreader on F550. Did maintenance on chain saw and pole saw.

**Supervisor Sangialosi motioned to amend the agenda to appoint auditor, seconded by Supervisor Batt. Vote unanimous.**

**Supervisor Sangialosi motioned to appoint Deb Minck as township auditor, seconded by supervisor Batt. Vote unanimous.**

**Planning Committee Chairman, Andre Weltman mentioned he is going to try to reach out to personnel about township addresses again.**

**Supervisor Sangialosi gave update from the WCCOG meeting. Mike Hartman, MDIA Senior Inspector/Camp Hill Office Manager spoke to the members about MDIA regrouping. A new building permit inspection requirement sheet was handed out to be given to residents. It was reported that Representatives Ecker and Gleim and Senator Rothman met with Acting Secretary of DEP concerning Food Processing Residuals.**

**Governor Shapiro passed legislation concerning an increase in the 911 funding fee.**

**Emergency Coordinator, Robert Kough, Jr. discussed the requested approval for the Camp Michaux Gravel Grinder bike race. An emergency action plan, Penn Dot certified flaggers for traffic control at Rt. 233/Ridge Rd. and to add Cooke Township as additional insured is needed. Supervisor Sangialosi motioned to give conditional approval to Camp Michaux Gravel Grinder bike race, seconded by Supervisor Batt. Vote unanimous.**

**Andre Weltman reached out to Mr. Kistler concerning building a house on property that includes a house presently. Mr. Kistler replied that the old house would be demolished after the new house is completed. A new permit would be needed for the new house.**

**Supervisor Sangialosi motioned for Solicitor McKnight to look into a demolition permit resolution, seconded by Supervisor Batt. Vote unanimous.**

**Supervisor Batt motioned to sign the Quarry Bridge intergovernmental cooperation agreement that was reviewed by Solicitor McKnight, seconded by Supervisor Strayer. Vote unanimous.**

**Resident Becky Moorehead read from the Constitution.**

**Emergency Coordinator, Robert Kough Jr. reported on an emergency call in the state park.**

**Supervisor Sangialosi motioned to adjourn the meeting, second by Supervisor Batt. The meeting adjourned at 8:24 P.M.**
